



Limited Leak-Proof Guarantee And Limited Lifetime Warranty

GutterDeck Limited Leak-Proof Guarantee:

Robco Manufacturing, Inc. guarantees, to the original end user, that the GutterDeck system will not leak from the joint seams in normal wet weather conditions when properly installed according to the GutterDeck installation guide and provided that the drainage channels remain unobstructed. If the deck planking joint seams leak during the lifetime of the structure on which the GutterDeck system was originally installed, Robco Manufacturing, Inc. will provide replacements for all of the GutterDeck components that are found to be defective during this time period. All warranties are subject to the terms and conditions noted within.

GutterDeck Limited Lifetime Warranty:

Robco Manufacturing, Inc. warrants, to the original end user, all components of the GutterDeck system to be free from manufacturing and structural defects, during the lifetime of the structure on which the GutterDeck system was originally installed. Robco Manufacturing, Inc. will provide replacements for all of the GutterDeck components that are found to be structurally defective during this time period. All warranties are subject to the terms and conditions noted within.

Limitations:

This limited lifetime warranty is exclusive and in lieu of any and all other warranties, expressed or implied, including without limitation, any implied warranty of merchantability or fitness for a particular purpose, except with respect to the replacement of defective product as described herein. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. This warranty does not apply to, and Robco Manufacturing, Inc. makes no warranties, expressed or implied with respect to: (1) improper installation or failure to conform to the GutterDeck installation guidelines; (2) use of the GutterDeck system for purposes other than those approved by Robco Manufacturing, Inc.; (3) failure to conform to local building codes; (4) misuse, neglect or improper maintenance; (5) exposure to chemicals or conditions harmful to aluminum; (6) excessive loads or impact by foreign objects; (7) minor discoloration of materials, normal wear, weathering, or pollution; (8) damaged to painted surfaces not caused by manufacturing defects; (9) acts of God (including, but not limited to, tornado, hurricane, earthquake, lightning, falling debris, storm damage); (10) distortion, settling, unevenness, or collapse of the ground or the supporting structure on which the GutterDeck system is installed; (11) This warranty shall not cover and Robco Manufacturing, Inc. shall not be responsible for the cost and expenses incurred with respect to the removal of an incorrectly installed GutterDeck system or installation of defective decking. Robco Manufacturing, Inc. shall not be responsible or held liable for: (1) any removal, repair or installation services not approved by Robco Manufacturing, Inc.; (2) any shipping, ancillary materials or labor required to fulfill warranty claim; (3) any direct or indirect, incidental, punitive, consequential, exemplary or other damages of any kind whatsoever related to the goods delivered hereunder, whether such claim is based upon theories of contract, warranty, negligence, tort, struck liability or otherwise. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. If your state does not allow the exclusion of implied warranties or limitation of incidental or consequential damages, any such implied warranties, including warranties of merchantability or fitness for a particular purpose, are limited to ninety days from the date of original bill of sale. Robco Manufacturing, Inc. reserves the right to determine, in its sole discretion, whether or not a defect exists for which it may be responsible under this warranty. Use of components not manufactured for the deck planking product installation voids this warranty. This warranty does not apply if deck planking is modified or altered whatsoever. Robco Manufacturing, Inc. reserves the right to discontinue or change any GutterDeck product. If product installed is no longer available, Robco Manufacturing, Inc. will have the right to substitute a compatible deck planking product. Exchanged parts or components furnished by Robco Manufacturing, Inc. under this warranty will have the standard color and or specifications available at that time. Color variances may occur with replacement components. Color variances from manufacturing lots are characteristic and are not considered a defect. A color variance may occur between the new or exchanged components in comparison to the original product, and would not be indicative of a defect in the product. This warranty is governed by the laws of the state of North Carolina and the North Carolina state courts shall be the exclusive forum for all actions or proceedings between parties of this warranty. This warranty gives you specific legal rights, and you may also have other rights, which vary from state to state.

Warranty Claims:

Original purchaser or end user must provide to Robco Manufacturing, Inc., at the address below, notice of the possible defect within 30 days of discovery and include original proof of purchase, photographs of the defect, and a written description of the defect. Robco Manufacturing, Inc. must be given 60 days and granted access to the property to inspect the defect and assess the origin of the problem. Warranty claims should be directed to:
